



## How to pay Cyprus Annual Company Levy

Please follow instructions below to pay the Annual Company Levy of your Company:

 Please follow the link to <u>https://www.jccsmart.com/account/new-customer</u> and register yourself with jccsmart. If you already have an account you can go directly to the login page at <u>https://www.jccsmart.com/account/log-on</u>. You can create an account under your name or under your Company's name.



2. After you register and login, click on **Organizations** (<u>https://www.jccsmart.com/outlets</u>), then go under letter A and choose 'Annual Company Fee'

3. On the next screen you need to choose the year for which the payment you are trying to make relates to. Scroll Down to Year 2023 and click 'Bill Payment'.



4. Next you need to include the registration number of your company and the amount you are paying for (it should be €350, unless you have incurred any penalties).

You can find the registration number of your Company on the Corporate Certificates you received upon incorporation of your Company or through a quick search of your Company name on the Registrars website <u>here</u>. Please make sure to add **HE** in front of the registration number.
